DECISION

According to the addendum to the TD for food-grade non-alcoholic powder concentrate "T8-TEO", developed by "Vilavi EU" EOOD, it is clear that the product you want to put on the Bulgarian market is a non-alcoholic powdered concentrate intended for preparation at home soft drinks by diluting into plain or mineral water, and also as a raw material for the production of non-alcoholic beverages. It follows from the above that "Vilavi EOOD" Ltd can sell the above-mentioned product on the Bulgarian market, labeled in Bulgarian, and its spelling is with compliance with Regulation (EU) No 1169/2011 of the European Parliament and of the Council of 25.10.2011. on the provision of food information to consumers, amending Regulations (EC) No 1925/2006 of the European Parliament and of the Council and repealing Commission Directive 87/250/2006, Council Directive 90/496 / EEC, 1991 . Directive 2001/13 / EC of the European Parliament and of the Council, Directive 2002/67 / EC and Commission Directive 2008/5 / EC and Commission Regulation (EC) No 608/2004.

According to the Supplementary Provisions of the Foodstuffs Act, paragraph 1, item 71 "Food supplements" are foods, intended to supplement the normal diet, and which are concentrated sources of vitamins and minerals or other substances with a nutritional or physiological effect, used alone or in combinations which are marketed in dosage forms such as capsules, tablets, pills, and the like, in powder form, ampoules with liquids and other similar liquids or powders formulated to be administered in pre-sized small quantities is.

Recommendations: To translate the label of the above-mentioned product into Bulgarian in accordance with the requirements of Regulation (EU) No 1169/2011
